We charge a vendors a flat fee of 6% on all sales to cover credit card transaction fees, bags, fragile item wrapping, marketing, website maintenance, employee costs and other service related expenses. We do not require vendors to supply hours to the store.

Rustic Ridge will run "store-wide" sales of 5%-10% of occasionally 3-4 times annually.

We suggest that vendors add in approximately 10% in their merchandise prices to help defray the cost of this fee, store wide discounts and/or booth/displays.

All booth and display fixture rentals are subject to availability and application approval. In the event there is no availability, you will be added to our waiting list for consideration when space opens.

In order to maintain a cohesive retail experience for the customers, RUSTIC RIDGE management has set forth guidance with regards to what merchandise VENDORS will be allowed to display for sale on the premises.

1) Acceptable Merchandise:

- a) Quality antiques and retro items
- b) Quality hand-crafted items
- c) Collectable items such as records, toys, cards and figurines
- d) Sports memorabilia
- e) Candles, soaps, essential oils, perfumes and incense
- f) Primitive or rustic home décor items
- g) Decorative glass such as figurines, hand-blown glass and crystal.
- h) Pottery
- i) Local artworks such as paintings, sketches, sculptures and woodworking.
- j) Jewelry
- k) Gift Baskets
- l) Models and model kits
- m) Holiday décor
- n) Vintage farm equipment, tools and outdoor décor
- o) Miniatures such as doll houses, doll house furniture, scale railroad items and Christmas villages.
- p) New and/or quality used fishing poles, lures and tackle boxes.
- q) Historical items
- r) *Vintage record players or VHS players
- s) *Game consoles and game disks.
- t) *Collectable CD's, VHS tapes, cassette tapes and record albums.

2) Unacceptable Merchandise:

- a) New and/or used electronics not listed under Acceptable Merchandise.
- b) New and/or used furniture not listed under Acceptable Merchandise.
- c) New and/or used toys that are widely available with no collectable value.
- d) Food items such as mass-produced items that are widely available.
- e) Craft supplies such as yarn, mesh and unfinished projects.
- f) Broken items.
- g) New and/or used clothing or shoes not listed under Acceptable Merchandise.
- h) Automobiles, part, boats, recreation vehicles, trailers, farm equipment and similar items not listed under Acceptable Merchandise.
- i) New and/or used dishware, bakeware or cutlery that is widely available with no collectable value.
- j) Living animals, pets, used pet supplies and bait.
- k) Knives, guns, ammo, fireworks, explosives or anything that may be considered a weapon not listed under Acceptable Merchandise.
